Booking / Refund / Cancellation Policy – courses and events

The following booking /refund / cancellation policy applies to any event, workshop or training course that Edibles delivers.

Course / event places will only be confirmed on receipt of payment.

After payment if the participant chooses to cancel the following conditions will apply.

- more than 30 days notice of cancellation, a full refund will be made minus a £5.00 administration charge.
- 15-30 days notice of cancellation 75% of the fee will be refunded minus a £5.00 administration charge.
- 6-14 days notice of cancellation 50% of the fee will be charged minus a £5.00 administration charge.
- 5 days or less notice of cancellation 100% of the fee will be charged.

If the participant can find a replacement for their place on the course then no cancellation fee will be charged.

If Edibles needs to cancel the course or event, through lack of attendees or exceptional circumstances, we will refund 100% of any fees already paid. We will inform participants no less than 21 days before the course / event date.
